ITC Update

Brent Weber, Vice President of Intercontinental Terminals Company (ITC), presented a short briefing and status report regarding its March 2019 fire. Weber discussed which entities are investigating, the status of their infrastructure and demolition process, repairs to Tidal Road at Independence, and remediation activities overseen by the Texas Commission on Environmental Quality (TCEQ). Attendees were invited to ask

questions, which will be added to a list of questions about the ITC fire from members of CACs/CAPs/CIP for future discussions on emergency response and lessons learned.

Questions

- At this point, what are you doing differently/what has changed as a result of the fire?
- What is the timeline for lawsuits to be filed? Have they begun? Is there an end date?
- Can you remind us what started the fire?
- What kind of products do you store at your facility?

<u>Process Safety Management (PSM):</u> <u>Managing Hazards to Reduce Frequency and Severity of Incidents</u>

Trilby Cressman of Evonik Oil Additives presented an overview of the Occupational Safety and Health Administration (OSHA) Process Safety Management (PSM) program, including who participates and why, OSHA's role, and the fourteen elements of compliance. OSHA requires employers that use or store highly hazardous chemicals in the threshold quantities (available in Appendix A) to follow the Process Safety Management Standard, which was designed to protect workers from hazards associated with the use of highly-hazardous chemicals in a process. The requirements, when implemented successfully, greatly reduce the chances of a catastrophic event from occurring. The fourteen elements of compliance are:

- Employee Participation
- Process Safety Information
- Process Hazard Analysis
- Operating Procedures
- Hot Work Permits
- Management of Change
- Pre-Startup Safety Reviews

- Mechanical Integrity
- Emergency Planning
- Incident Investigation
- Contractors
- Training
- Compliance Audits
- Trade Secrets

Question: Are there any attempts by the current administration to undermine OSHA rules like **PSM?** Not at this time. We have seen changes being made to the Clean Water Act and Clean Air Act, but nothing involving OSHA or PSM.

Question: How come the chemical plant that exploded in West, Texas had hazardous chemicals but was not covered by PSM? PSM is industry specific. The explosion in West, Texas, was at a storage facility, and it has to do with how they are classified.

Updates

Question of the Month from Hexion

Hexion Show and Tell

Hexion produces BPA, Liquid Resins and Solid Resins. These products are used in can linings (such as those used for canned food items), adhesives, engineering coatings, aerospace and electrical products, polycarbonate

lenses and wind turbine blades.

Level 2 Watches or Level 3 Warnings

Jeff Garry with Dow Chemical reported a Level 2 Watch from Tuesday, February 18, when material reacted in their sewer, forming less than one pound of NOx. It occurred near the fence line so they reported it, but there was no impact beyond their fence line.

Doug Moore with Lubrizol reported a Level 2 Watch from this morning, February 24, when four barrels of sludge reacted with rainwater, forming hydrochloric acid. They monitored the fence line, enclosed the drums, and are neutralizing the contents to prevent further issues. There was no impact beyond the fence line.

Paul Kanters with Vopak reported a Level 3 Warning from the beginning of February, when a barge at their dock discharged 5 gallons of MDI into the ship channel. Boom was deployed, and it was determined to be caused by a manifold failure which is the barge owners responsibility.

Amanda Accardo with Shell Deer Park reported a Level 2 Watch in late January when they discovered liquid on a floating tank roof. Shell had another Level 2 Watch issued in February for an exceedance of benzene emission, which will be addressed in their next turnaround. There was no fence line exceedance found for either of these two watches.

Written Facility Updates

Evonik Oil Additives reported no spills, releases, permit exceedances or recordable injuries during the reporting period, from September 2019 to February 2020. They celebrated 5 years in October with no OSHA recordable injuries or illnesses. The Deer Park plant serves as a leader and teacher for Evonik sites worldwide on Total Productive Management program. Among six topics for the Fall 2019 Safety Day were compliance training, tabletop emergency response drills, and the video "Remembering Charlie."

Valvoline reported no spills and one finger injury during the reporting period. The EPA audited their Facility Response Plan and Stormwater, Pollution Prevention and Countermeasure Plan in March. They are working to improve sustainability and recycling, and continue promoting safety through reporting of near misses and root cause analysis of incidents.

Vopak had no OSHA recordable injuries in 2019 and none year to date in 2020. They reported two leaks since August. Vopak received approval to build 7 new above-ground storage tanks. They also won the International Liquid Terminals Association safety award for the third year in a row.

Ozone Exceedance Days

TCEQ's Karen Lewis-Holmes reported there had been 33 days in 2019 when the Houston region exceeded the 8-hour standard, and 6 of those were in Deer Park. There were 3 days with 1-hour standard exceedances in the Houston Region, with one of those days in Deer Park. There have been no exceedances yet in 2020 YTD.

Other Plant Updates

Amanda Accardo announced her new role with Shell's Midstream group. Stephanie Meadows, the Internal Communications manager will continue to attend DPCAC meetings. The external communications manager will be announced soon.

Community Updates

Sheridan shared information about the upcoming **US Census**, which is required by the United States Constitution and has occurred every 10 years since 1790 to count the number of people living in the United States. Census Day is April 1. Invitations to respond to the 10-question census questionnaire will be mailed March 12-20. For the first year, responses may be made online. To obtain Texas's fair share of seats in the US House of Representatives and our fair share of more than \$675 billion in federal funds distributed to state and local government based on census data, a complete count is needed. By unanimous agreement, members adopted the 2020 EHCMA DPCAC Budget as presented by Treasurer Steve Horton.
