# DEER PARK CAC ROLE IN COMMUNICATIONS OF PLANT RISK MANAGEMENT PLANS

In the first of a series of meetings on the EPA Risk Management Program (RMP), facilitator Diane Sheridan described the role Deer Park CAC and other CACs played in helping plant members of the East Harris County Manufacturers Association communicate newly required Risk Management Plans (RMPs) in 1999. The 4 ½ year effort to develop plans and materials and hold public outreach events began in Deer Park CAC in November 1995. The second program in the series will be an overview in February 2021 of the EPA Risk Management Plan.

## **Written Facility Updates**

Clean Harbors Deer Park, LLC reported one lost time incident during the reporting period. The site is currently working on two permit modifications: RCRA (Resource Conservation and Recovery Act) permit to add a second mix building and TPDES (Texas Pollutant Discharge Elimination System) permit to add the ability to process non-hazardous wastewater.

Shell Deer Park reported three reportable emission events during the reporting period. The facility continues to promote safety by the roll out of a new behavior-based safety program, ACE, which will have trained, confident employees that complete peer-to-peer interventions. The site gave out over 90,000 pieces of PPE to local first responders. Among the recipients were Deer Park ISD and the Harris County Office of Emergency Management.

#### Level 2 Watches or Level 3 Warnings

Vopak Terminal Deer Park reported on a level 3 event that occurred on 9/13/2020, where a pinhole leak in a loading hose caused approximately 0.5 gallons of Linear Paraffins to be spilled into the Houston Ship Channel. A spill boat and absorbent boom were deployed for the clean-up.

#### **Ozone Exceedance Days**

TCEQ's Karen Lewis-Holmes reported there were seven new ozone exceedance days in the Houston Region in the month of October. Year-to-date there have been 28 exceedances of the 8-hour ozone standard in the Houston Region.

### **EHCMA DPCAC Treasury Committee**

Changing EHCMA DPCAC treasurers necessitated a variety of decisions covered by the following 8 motions.

- 1. Accept the resignation of Steven Horton as EHCMA DPCAC Treasurer. Horton shall remain a member of the Treasury Committee and a signatory to the EHCMA DPCAC bank account. His current term ends in 2-23.
  - a. Moved by Ruth Boyd and seconded. Passed unanimously.

- 2. Accept the resignation of Charles Thomas as a member of the Treasury Committee. His term expires in 2-21.
  - a. Moved by Ken Donnell and seconded. Passed with one nay.
- 3. Remove Charles Thomas as a signatory to the EHCMA DPCAC bank account once the bank has added his replacement.
  - a. Moved by Ken Donnell and seconded. Passed unanimously.
- 4. Add Cara Herbeck to the Treasury Committee to replace Charles Thomas to complete his term ending in 2-21 and then to serve a 3-year term expiring in 2-24.
  - a. Moved by Sherry Garrison and seconded. Passed unanimously.
- 5. Appoint Cara Herbeck as the Treasury Committee member who will serve as Treasurer and perform associated duties.
  - a. Moved by Marlene Mercado and seconded. Passed unanimously.
- 6. Appoint Cara Herbeck as a signatory to the EHCMA DPCAC bank account.
  - a. Moved by Marlene Mercado and seconded. Passed unanimously.
- 7. Confirm that Bobby Garcia remains a community member of the Treasury Committee, with a term expiring in 2-22.
  - a. Moved by David Wade and seconded. Passed unanimously.
- 8. Confirm that Marlene Mercado of Hexion remains a plant member of the Treasury Committee, with a term expiring in 2-23.
  - a. Moved by David Wade and seconded. Passed unanimously.

By previous decision, the members of the Treasury Committee serve as DPCAC's officers for banking purposes. EHCMA DPCAC Secretary, Anja Borski, serves as the Secretary. (DPCAC does not have a board of directors.)

DPCAC members thanked Steve Horton for his 4 years of service as Treasurer and Cara Herbeck for volunteering to assume the Treasurer's duties.
