#### **Annual Report on Emissions from CAC Plants**

Zoom presentation posted at www.deerparkcac.org on Member page

Christina Penrose of Lubrizol presented the Air Emissions Inventory and Toxics Release Inventory (TRI) for the Deer Park CAC plants. The Air Emissions Inventory is the collection and evaluation of criteria pollutants, which include total suspended particulates, sulfur oxides, carbon monoxide, and the ozone precursors volatile organic compounds (VOCs) and nitrogen oxides. The information is submitted to the TCEQ. The Toxics Release Inventory (TRI) is submitted to the EPA and tracks the management of certain toxic chemicals that may pose a threat to human health and the environment. Highlights from the Emissions Inventory and TRI are as follows. The "full presentation" includes explanations from each reporting plant for significant increases or decreases from 2018 to 2019.

#### **HIGHLIGHTS OF 2019 DATA ON EMISSIONS**

**NOTE:** Delta was removed from the report after resigning from the CAC. Intercontinental Terminals (ITC) made the decision to not report EI or TRI to the CAC for the 2019 reporting period. ITC is required to submit the EI to the TCEQ and has voluntarily reported TRI numbers to DPCAC for many years. To provide a better comparison for the 2019 data, all historical ITC data was removed from trends and tables for the 2019 report.

#### **Level 2 Watches or Level 3 Warnings**

Shell Deer Park provided a written report on a Level 3 CAER/EMERGE message from October 27 that was subsequently determined to qualify as a Level 1 odor complaint.

#### **Written Facility Updates**

Dow Deer Park Operations had no lost time incidents during the reporting period (April -November 2020). The last injury on site was in February 2020. The site reported one Notice of Violation, one Notice of Enforcement, and one reportable quantity exceedance.

GEO Specialty Chemicals had no lost time incidents during the reporting period (April -November 2020) and has completed 468 without a recordable injury. The site had no reportable spills or reportable air releases during the reporting period. In October, GEO received an amended Water Quality Permit and a draft renewed/amended Title V Air Quality Permit from TCEQ.

#### **Ozone Exceedance Days**

TCEQ's Karen Lewis-Holmes reported there were no new ozone exceedance days in the Houston Region in the month of November. Year-to-date there have been 28 exceedances of the 8-hour ozone standard in the Houston Region.

#### **Other Updates**

TCEQ announced new and improved emergency response assets, that includes a Rapid Assessment Survey van, which is capable of real-time analysis while on the move. She will be giving input as a CAP facilitator of so many Gulf Coast plant CACs. Sheridan was on the original RC Public Advisory Panel from 1988-2007.
