DPCAC Reviews the Characteristics of Communities within 10 Miles and 30 Miles of Area Refineries

A 2019 University of Texas Medical Branch (UTMB) study said there was a correlation between cancer rates of those living within 30 miles of a refinery and between the stage of a cancer and those living within 10 miles of a refinery. While the study data was not specific to Deer Park, the DPCAC Program Planning Committee wondered if the census data would confirm or counter stereotypes about Deer Park and other ship channel communities.

DPCAC was presented with data to better understand the characteristics of the communities that fall in those areas. Diane Sheridan presented data from the 2020 Census and the 2015-2019 American Community Survey that showed population, age, race and ethnic background, education, health, median income and poverty level in Deer Park and other area communities.

Updates

<u>Written Facility Updates</u> - Members received regular periodic plant updates in advance of the meeting but the facilitator asked the plants who reported this month to share one or two highlights from their update that they wanted members to know about.

- Evonik Oil Additives USA, Inc. Jim Bentinck–Smith said they have gone 7 years without an OSHA recordable injury or illness. They are currently in the process of revalidating their Process Hazard Analyses (PHAs), which are directly tied to worker and process safety. This is a sixmonth process.
- Valvoline Rob Shelton shared that four new positions of packaging technician have been
 added at the site. Valvoline has also developed a new product line for Wal-Mart, three gallons
 of oil in a box, which is similar to wine in a box and cuts down on plastic packaging.
- Vopak Terminal Deer Park Kathy Stewart reported a total recordable injury rate (TRIR) of 0.00 for 2021. Vopak completed a community engagement project to connect with younger people and they had 30 Deer Park students in their facility for a day. The students were able to participate in hands on demos, tours, and vendor demos.

<u>Ozone Exceedance Days</u> – Karen Lewis-Holmes reported that there have been zero ozone exceedances in the Houston Region for the month of February, adding that this is typical for this season.

Finances

<u>Treasury Groundrules Changes</u> – DPCAC facilitator Diane Sheridan presented revisions to the DPCAC treasury (finance-related) groundrules recommended by the DPCAC Treasury Committee. Committee members include Treasurer Cara Herbeck, Steven Horton, Bobby Garcia, and Marlene Mercado of Westlake Epoxy (formerly Hexion).

Sheridan explained how DPCAC handles income and expenses, and how that changed in 2002 and again in 2013. She explained the reasons for the proposed changes, section by section. Many proposals

codified decisions previously made but never put into the groundrules. The proposal was mailed to members approximately 2 weeks prior to the meeting.

Steven Horton of the DPCAC Treasury Committee then moved adoption of the proposed changes to the DPCAC groundrules related to finances. No second was required because the motion came from a DPCAC Committee. The motion passed.

Treasury Committee Business

By unanimous consent, East Harris County Manufacturers Association Deer Park Community Advisory Council members reappointed Bobby Garcia to the EHCMA DPCAC Treasury Committee. He will serve another 3-year term, ending in December 2024.

By previous decision, the members of the EHCMA DPCAC Treasury Committee serve as DPCAC's officers for banking purposes. The EHCMA DPCAC Secretary serves as the secretary. (DPCAC does not have a board of directors.)

By unanimous agreement, members adopted the 2022 EHCMA DPCAC Budget as presented by Treasurer Cara Horton Herbeck.
