Meeting Notes Monday, November 27, 2023

The 314th meeting of the Deer Park Community Advisory Council (DPCAC) was held on Monday, November 27, 2023, at the Republic Grill. Facilitator Anne Gowan reviewed the agenda, which was accepted as proposed. The October 2023 meeting notes were approved without changes.

Plant Host

Sharon Hulgan said that Dow just celebrated their 75th anniversary. In Deer Park, Dow produces paint coatings and acrylic acid absorbents that are used in paints that can be found at big box stores.

Updates

<u>Ozone Days</u> –Gowan reviewed the ozone exceedance data for the Houston Region and Deer Park that was provided by TCEQ. There were no exceedances in the Houston region in November.

<u>Written Facility Updates</u> – Members received regular periodic plant updates in advance of the meeting. Plants were asked to share one or two highlights from their update.

- Shell Chemical Deer Park –Nate Levin said Shell Deer Park has partnered with Make-A-Wish for
 the past three hyears, and this year was able to grant a local Deer Park boy's wish to visit
 Hawaii. Shell Deer Park is also hosting their annual toy drive for The Bridge Over Troubled
 Waters and Sarah's House and as well as a food drive to benefit the Pasadena Food Drive. The
 Women's Business Enterprise National Council Energy Executive program was also hosted at
 their site recently. Additionally, Shell Deer Park expects to start up the unit where they May 5th
 fire occurred in the next several weeks.
- PEMEX Deer Park Guy Hackwell reported that there was one emissions event since their last reporting period. The last recordable injury occurred on April 12, 2023. The first PEMEX Deer Park family day for employees was held at Minute Maid Park.
- Clean Harbors Bruce Riffle shared that Clean Harbors opened a new container storage area. They have had zero lost time incidents for two years. The Clean Harbors Deer Park landfill will be closing next year and all ash and filter cake will be shipped to Oklahoma for disposal.

Treasury Motions

Gowan said that as discussed in the October meeting, the *DPCAC Ground Rules Relating to Finances* need to be amended in order for DPCAC to participate in East Harris County Manufacturing Association's (EHCMA) centralized accounting system in 2024. Ground rule changes were emailed out to members on October 26th for review and discussion. All minor changes were incorporated into the version sent via email on November 21st for final review prior to the vote.

Motion #1: Amend Ground Rules Related to Finances was proposed by Treasurer Cara Herbeck, seconded by Tommy Ginn and approved by all present.

Motion #2: Adopt 2024 Budget was proposed by Treasurer Cara Herbeck, seconded by Jimmy Bracher and approved by all present.

The Return of Sticky Dots! Brainstorming and Prioritizing Program Topics for the Coming Year

DPCAC members reviewed the group's mission and purposes, as well as meeting topic history for DPCAC and other CACs in the area. Small groups brainstormed topics they would like addressed in the coming year. Small groups then proposed topics for listing on flip charts. Attendees used sticky dots to prioritize the topics they most wanted to address in the coming year. Community and plant reps used different colored stickers so they could be tallied separately. Input is attached at the end of the meeting notes. Community member Ruth Boyd volunteered to serve on the Program Planning Committee. The committee will meet to draft a program plan based on the group input. Once reviewed and adopted by DPCAC, it will form the basis of the agendas for meetings in 2024 and early 2025.
